NOTE:

- ◆ All fees are in Canadian funds, effective September 1st, 2017.
- ◆ Exchange Rate Policy: wire transfers, money orders, cheques or cash received by Bond International College/Bond Academy in US dollars is converted into CAD at the current exchange rate on the day the money is received.
- ◆ A Letter of Acceptance is only issued after the full payment is received (refer to the offering letter).
- ◆ Once the student has been granted a Study Permit, the student is expected to arrive at the first available admission date. If there is any change, please contact the Admissions Office.
- * Proof of insurance is required for all of the students while studying at Bond. While the school is not the insurer, the school has arranged an insurance provider to insure the students studying at Bond in Canada. Bond students are required to buy the Canadian insurance recommended by Bond. It will take approximately 2 weeks for the insurance coverage to be effective after the submission of the insurance application. Students are recommended to buy medical insurance to cover the period from the arrival date to the effective date.



- ◆ Uniform Fee is \$260 for boys (two shirts, two pairs of trousers, one cardigan and one necktie) and \$300 for girls (two shirts, one pair of trousers, one kilt, one cardigan and one necktie).
- ◆ Custodianship Legal Fee is a one-time legal fee to arrange custodianship in Canada for non-residence students.
- ◆ Custodianship Fee is a monthly fee paid to the custodian until the student reaches the age of 18 or the parent(s) arranges another custodian. Proof of alternative custodianship is required.
- ◆ Custodianship arranged through the school ceases when the student is no longer attending Bond, or no longer living in Bond Residence/Homestay, or reaches the legal age.
- ◆ Custodian Deposit is **NOT** refundable if the student under 18 moves out of the residence/ homestay without providing the school with the proof of a new custodian. It is also **NOT** refundable if the student arranges his/her custodian but fails to notify the school within 30 days in advance.
- ◆ Residence Deposit and Homestay Damage Deposit are refundable upon advance notice of one month (30 days) before moving out of Residence/Homestay and there are no damages or outstanding fees. Otherwise there is **NO** refund.
- ◆ All fees except Application Fee are refundable only if the student's application for Study Permit is refused by the Canadian Immigration authorities. For refund, students should submit the following documents:
 - Original letter of rejection from the Canadian Embassy or Consulate
 - Original letter from the student/parent of the student requesting the refund. A letter from an agent or other representative without the original letter from the student/parents is not acceptable.
 - Original Letter of Acceptance and Official Receipt from Bond.

STUDENT ACCOMMODATION AT BOND

Bond believes in an integrated approach to a student's educational experience while studying in Toronto. Student Residence

Bond International College has a student residence located within a ten-minute bus ride from the school.

Special requirement such as transportation or other needs can be arranged through the Homestay Coordinator. Additional charges may apply. Homestay features vary according to each home.
